

ARTICLES OF INCORPORATION
OF
STAT CARE OF CENTRAL FLORIDA, INC.

ARTICLE I - NAME:

The name of the Corporation is STAT CARE OF CENTRAL FLORIDA, INC.

ARTICLE II - DURATION:

This Corporation shall have perpetual existence from the date commencing on the date of execution and acknowledgement of these Articles.

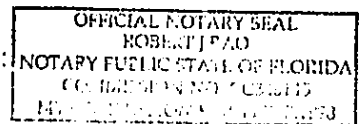
