# ARTICLES OF INCORPORATION OF COLORS IN BLOOM, INC. A FLORIDA FOR PROFIT CORPORATION

The undersigned natural person(s) competent to contract, hereby make, subscribe and anknowledge these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the state of Florida.

### ARTICLE I - NAME

# ARTICLE IV - REGISTERED OFFICE AND REGISTERED AGENT

#### ARTICLE IX - SPECIAL PROVISION

The following special provisions, power, privileges, and limitations shall be applicable to and govern this Corporation.
