

Article I - Name

The name of this corporation shall be: TIKI TRADERS, INC.

Article II - Duration

This corporation shall have a perpetual existence.

Article III - Purpose

This corporation is organized to engage primarily in the business of import and export products for wholesale and retail distribution; and for transacting any or all lawful business permitted for corporations organized under Chapter 607 of the Florida Statutes as presently in effect or as may hereafter be amended.
