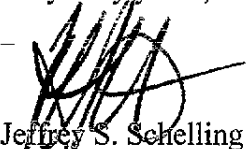

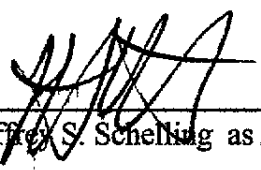
ARTICLE I. NAME

The name of the Corporation is "Jeffrey S. Schelling, P.A."

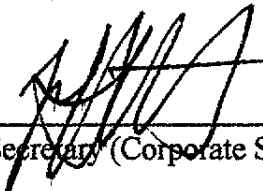
2. In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
