**ARTICLES OF INCORPORATION  
of  
G.B. NELSON AND NELSON , INC.**

**ARTICLE I—NAME**

1. **NAME.** The name of the corporation is **G.B. NELSON AND NELSON, INC.**

**ARTICLE II—PRINCIPAL OFFICES**

1. **PRINCIPAL OFFICE.** The principal office of the corporation shall be established and maintained in the city of Fort Walton Beach, County of Okaloosa, State of Florida.

2. **MAILING ADDRESS.** The mailing address of this corporation shall be:  
656 Country Club Avenue, Fort Walton Beach, Florida 32547.

3. **OTHER OFFICES.** The corporation may have other offices at other places and in any state which the board of directors ("the board") may establish from time to time.

**ARTICLE III—SHARES**

1. **CERTIFICATES FOR SHARES.** Certificates representing shares of the corporation shall be in the form prescribed by the board. Such certificates shall be signed by the president and secretary and sealed with the corporate seal. Each certificate shall be consecutively numbered. The name and address of the rightful shareholder and the number of shares and date of issue shall be entered on the stock transfer books of the corporation. In case of a transfer of ownership of shares, no new certificate shall be issued until the former certificate for the equivalent number of shares has been surrendered and canceled. In case of a lost, destroyed or mutilated certificate, a new one may be issued upon such conditions as the board may set down.

2. **TRANSFER OF SHARES.** Shares of the corporation shall be transferred only on the stock transfer books of the corporation by the holder of record or his legal representative. A request for transfer shall be accompanied by proper evidence of authority to transfer, and on surrender for cancellation of the former certificate for such shares. For all purposes, the person in whose name shares are registered in the books of the corporation shall be deemed to be their owner.

3. **SHARES.** The corporation shall have authority to issue 500 shares, all of one class, \$10.00 par value.
