#### OPTOMETRY ASSOCIATES, P.A.

ARTICLE I

NAME

The name of this corporation shall be OPTOMETRY ASSOCIATES, P.A.

#### ARTICLE II

DURATION

This corporation shall exist perpetually.

#### ARTICLE III

#### **PURPOSE**
