ARTICLE I - NAME

The name of this corporation is Precision Master Home & Building Improvements, Inc.

ARTICLE II - PURPOSE

This corporation is organized for the purposes of conducting a business engaging primarily in structural improvements including remodeling and maintenance to residential and commercial buildings. To transact any or all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

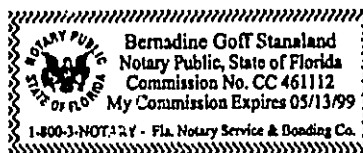

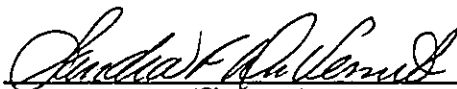
