ARTICLES OF INCORPORATION
UNDER THE FLORIDA STATUTES
BEAUTYLAND SCHOOL, OF COSMETOLOGY, INC. TALLAHASSEE, FLORIDA

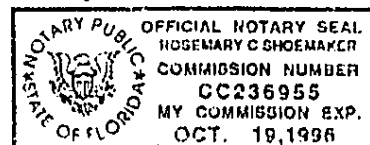
