

ARTICLES OF INCORPORATION
OF
BRS CONSULTING SERVICES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be BRS CONSULTING SERVICES, INC.

ARTICLE II PRINCIPAL OFFICE

The street address of the principal office is 2920 Harpoon Lane, St. James City, FL 33956, and mailing address of this corporation shall be 2920 Harpoon Lane, St. James City, FL 33956.

ARTICLE III CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is SEVEN THOUSAND FIVE HUNDRED (7,500) SHARES, consisting of one class only designated as "common stock," with par value of \$1.00 per share.

The Stock of the corporation shall be restricted as to transfer as follows, which restriction shall be imprinted upon the stock certificates issued by the corporation:

No stock of the corporation shall be transferred until such transfer has been proposed in writing to the Board of Directors of the corporation by written proposal filed with them stating the number of shares to be transferred, the price per share, and the name of the transferee. The Board of Directors shall within sixty (60) days after receipt of such proposal either consent to the transfer or furnish a purchaser for the shares at the same price. Failure of the Directors to act upon such a proposal within sixty days after receipt thereof shall be deemed to consent by them to the proposed transfer. No such proposed transfer shall be made until the aforesaid sixty (60) days have expired or the Board of Directors have consented thereto.

ARTICLE IV INITIAL REGISTERED AGENT AND ADDRESS

The name and address of the initial registered agent is ELIZABETH A. HAESEMEYER of 3548 Tangerine Drive, St. James City, FL 33956, and the designated agent by her signature hereon, does

hereby accept the appointment as registered agent pursuant to the provisions of Section 607.034, Florida Statutes.

ARTICLE V INCORPORATOR(S)

The name and street address of the incorporator to these Articles of Incorporation is ELIZABETH A. HAESEMEYER at 3548 Tangerine Drive, St. James City, FL 33956.

ARTICLE VI DIRECTOR(S)

The number of the directors constituting the initial Board of Directors of the corporation is two (2), and thereafter the number of directors shall be such number as is fixed from time to time by the by-laws. The initial Board of Directors shall be the following: ELIZABETH A. HAESEMEYER, 3548 Tangerine Drive, St. James City, FL 33956 and SHIRLEY M. SNYDER, 2920 Harpoon Lane, St. James City, FL 33956.


ARTICLE VII PERIOD OF EXISTENCE

The period of its existence is perpetual.

ARTICLE VIII PURPOSE

The purpose or purposes for which this corporation is organized is to engage in any lawful activities within the purposes for which a corporation may be organized under the Florida Business Corporation Law (Chapter 607 of the Florida Statutes).


