ARTICLE I - NAME

The name of this corporation is CREATIVE BEGINNINGS, INC.

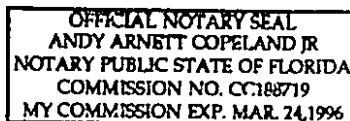
