These Articles of Incorporation are adopted for the purpose of forming h corporation under the laws of the State of Florida, to be filed with the Florida Department of State, as follows:

#### ARTICLE ONE: NAME

The name of the corporation is Christopher Mark Building & Renovation, Inc., and its mailing address shall be 4808 South Tamiami Trail, Suite 208, Sarasota, Florida 34231, until and unless such address is subsequently changed by the corporation.

## ARTICLE TWO: COMMENCEMENT AND DURATION

The corporation shall commence its corporate existence upon the filing of these Articles of Incorporation with the Florida Department of State and it shall exist perpetually thereafter until dissolved according to law.

## ARTICLE THREE: PURPOSE

The corporation shall have the authority to issue 1000 shares of common stock with a par value of 1.00 per share. Each Shareholder of the corporation shall have the first right to purchase shares and securities convertible into shares of any class, kind or series of stock in the corporation that may from time to time be issued, whether or not presently authorized, including shares from the treasury of the corporation, in the ratio that the number of shares the Shareholder holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares preempted within thirty days after receipt of a notice in writing from the corporation, stating the price, terms, and conditions of the issue of shares, and inviting the Shareholder to exercise such preemptive rights.
