The Articles of Incorporation of Ridgewood Orlando, Inc. are as follows:

ARTICLE I

The name of the corporation is Ridgewood Orlando, Inc.

ARTICLE II

The corporation shall have perpetual duration.

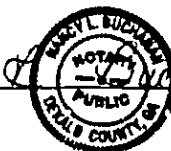
