In July, 19~~8~~⁹6 I called your agency as to why I had not received a renewal for my Corporation. I was told it was sent out in May to 13747 N.E. 7th Ave which was the wrong address. The papers by error were filed 13747 N.E. 7th Ave, the correct address is 13747 N.W. 7th Ave.

I received a letter from Tallahassee that due to this error if "I completed the form along with the covering letter and \$233.75 my Corporation would not be dissolved".

In completing the form I left off the Presidents name so the papers had to be resubmitted.

The original letter is missing from the corporate form. The form is now accompanied with a different letter dated 10/21/96 now dissolving the Corporation and asking for an additional fee.
