ARTICLES OF INCORPORATION
OF
J.T. ENTERPRISE IMPORT & EXPORT, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

J.T. ENTERPRISE IMPORT & EXPORT, INC.

ARTICLE II. NATURE OF BUSINESS
