**ARTICLES OF INCORPORATION OF HAYMON CONSULTING AND RESEARCH P.A.**

The undersigned adopt the following articles of incorporation for the purpose of forming a corporation under the Florida Professional Corporation Act and Limited Liability Company Act:

**ARTICLE I - NAME**

The name of the corporation is HAYMON CONSULTING AND RESEARCH, P.A.

**ARTICLE II - DURATION**

The corporation shall exist perpetually.

**ARTICLE III - PURPOSE**

The purposes for which the corporation is organized are:

- a. To render professional psychological services to the public and to transact such other business as may be allowed by such professional service corporation incorporated under the Florida Professional Corporation and Limited Liability Act;
- b. To do such things as are incidental, necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which the corporation is authorized to issue is 6,000 shares. Such shares shall be of a single class and shall have no par value.

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the corporation is 345 South Magnolia Drive, Building E Suite 17, Tallahassee, Florida 32303, and the name of the initial registered agent at such address is Sandra W. Haymon.

The Board of Directors from time to time may move the registered office to any other address in the State of Florida.

#### ARTICLE VI - BOARD OF DIRECTORS

The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one. The name and address of the initial director is:

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written instrument manifesting their intention that a certain amendment of these Articles of Incorporation be made.

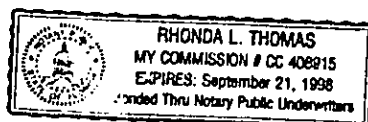
