# ARTICLES OF INCORPORATION OF <u>IMAGE SETTERS, INC.</u>

The undersigned, for the purpose of forming arApproxition under the Florida General Corporation Act, hereby adopts the following articles of incorporation:

# ARTICLE I NAME

The name of the Corporation is IMAGE SETTERS, INC.

# ARTICLE II DURATION

The term of existence of the Corporation is perpetual.

## ARTICLE III NATURE OF BUSINESS

The nature of the business to be conducted by the Corporation is:
