ARTICLES OF INCORPORATION

OF

The Undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name and principal address of the corporation is UNIWORLD ELECTRONICS, INC., at 75 East Flagler Street, Miami, Florida 33132.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

PURPOSE
