The undersigned Subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms this corporation for profit under the laws of the State of Florida, and does hereby do such under the following conditions:

**ARTICLE I.
Name Corporation**

The name of this corporation is C.T. Chukker & Co. II., but said corporation may use such other names, marks and designations as is authorized by the law and the Board of Directors of the Corporation.

**ARTICLE II.
Purpose of Corporation**

This corporation is organized and created under the laws of the State of Florida, and may engage in such activities as is permitted under the laws of the State of Florida and the United States.

**ARTICLE III.
Capital Stock**

This corporation shall have the power to issue one hundred (100) shares of stock, all of one class and all of a par value of One Dollar (\$1.00) per share, fully paid and non-assessable. But, the By-Laws of said corporation may authorize additional shares of stock of the same or different class with the same or different par value.

**ARTICLE IV.
Term of Existence**

This Corporation shall have a perpetual existence unless dissolved voluntarily or by action of law. This corporation shall commence its

**ARTICLE VIII.
Indemnification**

The corporation shall indemnify and hold harmless any Subscriber, Officer or Director of the Corporation to the full extent permitted by law.

**ARTICLE IX.
Amendment**

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment thereto, and any right conferred upon any shareholder is subject to this reservation.

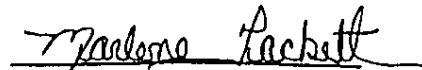

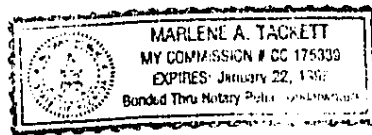
