# ARTICLES OF INCORPORATION OF AEN LIMOUSINE SERVICE, INC.

The undersigned, for the purposes of forming a corporation under the Florida Corporation Act hereby adopts the following Articles of Incorporation:

#### ARTICLE ONE NAME

The name of the corporation is A&N Limousine Service, Inc.

# ARTICLE TWO DURATION

The term of existence of the corporation is perpetual.

# ARTICLE THREE PURPOSE
