ARTICLES OF INCORPORATION  
PANTECHNOLOGY, INC.

Article 1. Name. The name of the corporation is:  
PANTECHNOLOGY, INC.

Article 2. Principal Office. The principal office of the corporation shall be located at: 909 Ivanhoe Circle Wimauma, FL 33598

Article 3. Stock. The number of shares the corporation is authorized to issue is ten thousand (10,000). There shall be one class of shares, which is common and each share shall have a par value of .10c. The rights of each shareholder shall not vary as to relative rights and preferences among shares. The corporation elects to have preemptive rights.

Article 4. Registered Agent. The street address of the corporation's initial registered office is 909 Ivanhoe Circle Wimauma, FL 33598 and the name of its initial registered agent at that address is H. Paul Koppehele.
