The undersigned, Zena M. Dickstein, being a duly elected Vice President of LENNAR MAYFAIR HOLDINGS, INC., a Florida corporation (the "Corporation"), hereby states as follows on behalf of the Corporation:

1. The Articles of Incorporation of the Corporation, Articles as heretofore amended (as amended, the "Articles") were filed with the Secretary of State of the State of Florida on June 14, 1995, under Document Number P95000045956.

2. Pursuant to the requirements of Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned hereby certifies, attests and serves notice that the Articles of the Corporation are hereby amended and restated in their entirety to read as follows, which Amended and Restated Articles of Incorporation incorporate amendments to all articles of the Articles of the Corporation:

ARTICLE I -- NAME

The name of this corporation is LNR MAYFAIR HOLDINGS, INC. (the "Corporation")
