
Please be informed that in the year 2004, the Florida Department of State, Division of Corporations has not sent out the necessary forms to file the Annual Report as was customary. Instead, all Florida corporations received folded fliers, with instructions to detach and mail back the postcard to request the forms.

NetSide Corporation did return the postcard via U.S. Mail as soon as it was received to request the forms. The Florida Department of State, Division of Corporations failed to send the 2004 Annual Report forms after they were properly requested according to the instructions on the postcard.

On or about July 3, 2004 we received a postcard with a "NOTICE OF INTENT TO DISSOLVE" message. I have personally called the Division of Corporations on July 6, 2004, explained to the clerk that we have never received the 2004 Annual Report forms for the two corporations that I am responsible for, and requested the forms be mailed. At the time, the clerk advised that we should include the \$150.00 fee and a note explaining the circumstances with our reports for each corporation.

We respectfully petition the Division of Corporations to waive the late penalty, as you have changed the traditional procedure of mailing out forms at the beginning of the new calendar-year, and you have not sent us the 2004 Annual Report forms when we first requested them via U.S. Mail. NetSide Corporation has always paid its invoices timely, but it is reasonable to expect that we first receive a proper and timely paper invoice. Thank you for your consideration.
