#### NA INTERNATIONAL, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE ONE NAME

The name of the corporation is NA INTERNATIONAL, INC.

## ARTICLE TWO DURATION

The duration of the corporation is perpetual.

## ARTICLE THREE PURPOSE

The corporation may transact any and all lawful business for which corporations may incorporate under the Florida General Corporations Act.

#### ARTICLE FOUR CAPITAL STOCK
