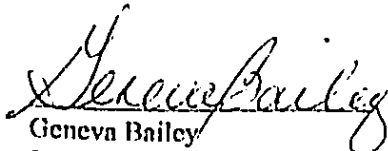

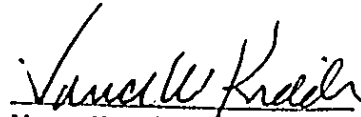
ARTICLE VI - INITIAL DIRECTORS
