ARTICLES OF INCORPORATION

OF

Davie Urgent Care & Family Practice, Inc.

ARTICLE - I

The name of this corporation is Davie Urgent Care & Family Practice, Inc.

ARTICLE - II

This corporation shall have perpetual existence commencing on the date of this filing of these articles with the Secretary of State.

ARTICLE - III

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized in Florida to engage in other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Florida Corporation's Code.

ARTICLE - IV

This corporation is authorized to issue only one class of stock which shall be designated common stock. The total number of shares it is authorized to issue is Five Hundred (500) Shares, at \$1.00 par value per share.

ARTICLE - V

The street address of the initial registered office of this corporation is 3538 S. University Drive, Davie, Florida 33328 and the name of the initial registered agent of this corporation at that address is Richard Allen Hill. The corporation's principal address and the registered office address are the same as the initial registered office address.

ARTICLE - VI

This corporation shall have one director constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the bylaws; however, there shall never be less than one Director nor more than five.
