ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name and physical address of this Corporation is Natural Accent, Inc., 3821 Gatewood Drive, Sarasota, FL 34232.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on this date of this filing of these Articles with the Department of State.

The Corporation shall indemnify any Officer or Director or any former Officer or Director, to the full extent permitted by law.


ARTICLE X - STOCK TRANSFER RESTRICTIONS




