**ARTICLES OF INCORPORATION
FOR
WEST END PRODUCTIONS, INC.**

I, Lee Munizzi, a natural person of lawful age, do hereby act to form a corporation under Chapter 607, Florida Statutes, and do hereby adopt the following Articles of Incorporation.

ARTICLE I

2. **NAME.** The name of this Corporation shall be West End Productions, Inc.

ARTICLE II

3. **NATURE AND EXISTENCE OF BUSINESS:** This Corporation shall employ those powers as may be provided, authorized or permitted by law or otherwise. It is intended that this Corporation shall have the right to engage in any business or activity that is not expressly prohibited by the applicable laws of the United States of America or the State of Florida . This Corporation shall have perpetual existence.

ARTICLE III

4. **CAPITOL STOCK.** The maximum number of shares of stock of West End Production, Inc., which the Corporation is authorized to have outstanding at any one time is ONE HUNDRED (100) shares of common capitol stock each having no par value.

ARTICLE IV

5. **INITIAL REGISTERED AGENT AND OFFICE.** The initial registered agent and street address of the initial registered office of this Corporation is:

6. INITIAL BOARD OF DIRECTORS: The business of this Corporation shall be conducted and managed by a Board of Directors consisting of not less than one (1) member as fixed from time to time by the By-Laws of the Corporation. 8. BY-LAWS. The power to adopt, alter, amend, or repeal BY-LAWS shall be vested in the Board of Directors and the shareholders of this Corporation.

This right to indemnification shall be in addition to and not exclusive of all other rights to which any Director or Officer may be entitled by law, these Articles, the By-Laws of this corporation, or otherwise.

ARTICLE IX

10. AMENDMENT. WEST END PRODUCTIONS, INC., reserves the right to amend, alter, change, repeal, and revise any provision of these Articles of Incorporation, in the manner now or hereafter prescribed by statute or the By-Laws of the Corporation, and all rights conferred on shareholders herein are granted subject to this reservation.
