ARTICLES OF INCORPORATION THE ORLANDO SINGERS INC.

Articles of incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Law of Florida, do hereby certify:

First: The name of the Corporation shall be The Orlando Singers Inc.

Second: The place in this state where the principal office of the Corporation is to be located is the City of Altamonte Springs, Orange County. The mailing address will be 669 Jamestown Blvd. #2057, Altamonte Springs, FL 32714.

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Specifically this corporation is organized in order to support the arts by performing, for all those who wish to hear, live, inspired, high quality, sacred music.

Fourth: Members of the Board of Directors will be elected in the manner stated in Article III, Section 2 and Section 7 of the By-Laws of this Corporation.

Fifth: The initial registered agent of this Corporation will be Melanie Swecker. The registered office of the Corporation upon whom process may be served is located at 669 Jamestown Blvd. #2057, Altamonte Springs, FL 32714.

Sixth: The names and addresses of the persons who make up the initial Board of Directors of the corporation are as follows:

The manner of termination of membership in the corporation, the rights, upon termination of membership, of the corporation, members and the remaining members; the transferability or non-transferability of membership; and the distribution of assets upon dissolution or final liquidation are as specified in the By-Laws of The Orlando Singers Inc.

Seventh: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance to the purposes set forth in Article Third hereof. Not substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) and political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Eighth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 c 3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes of the such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
