## ARTICLES OF INCORPORATION OF ATLANTIC & PACIFIC ICs, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the state of Florida.

#### **ARTICLE I. NAME**

The name of the corporation shall be: Atlantic & Pacific ICs, Inc.

The principal place of business of this corporation shall be: 9035 Classic Ct., Orlando, Florida 32819

#### **ARTICLE II. NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

#### ARTICLE III. CAPITAL STOCK
