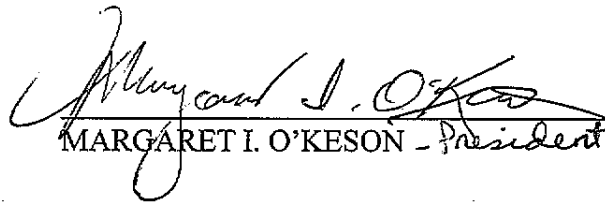

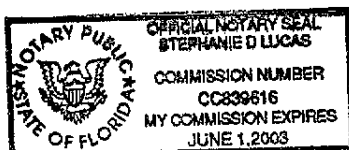

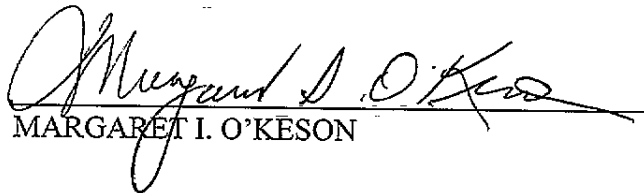
**SHAREHOLDER'S APPROVAL TO DISSOLUTION**
