ARTICLES OF INCORPORATION OF LEE MAX ROTHMAN, P.A.

The undersigned natural person, competent and licensed to practice chiropractic services in the State of Florida, acting hereby as Incorporator, for the purpose of forming a Professional Service Corporation for profit under the provisions of Florida Business Corporation Act, §607 of the Florida Statutes and the Florida Professional Service Corporation Act, §621 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Professional Service Corporation is: LEE MAX ROTHMAN, P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be: 2295 Corporate Blvd., NW, Suite 134, Boca Raton, FL 33431

ARTICLE III - PURPOSE

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of legal services, and all its fields of specializations, as are engaged in by lawyers.
