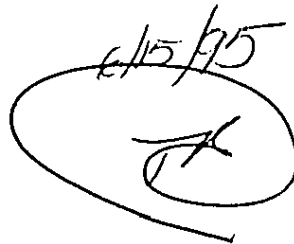

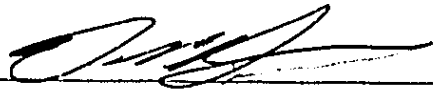
Article VII - Management by Shareholders
