ARTICLE 1 - NAME/ADDRESS

The name of this corporation is **RASPBERRY LANE, INC.** and its mailing and principal office address is 312 13th Street West, Bradenton, Florida 34205

ARTICLE 2 - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.


