ARTICLE I. CORPORATE NAME

The name of this corporation is **S.K. CONSTRUCTION OF DESTIN, INC.**

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

that a certain amendment of these Articles of Incorporation be made.

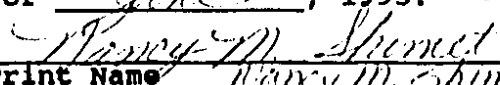

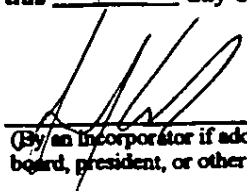
