ARTICLES OF INCORPORATION

A & H BEEPER & CELLULAR ACCESSORIES.

Shuling TALLAHE BELELDRIDA OF INC.

The undersigned incorporaror, for the purpose of forming a corporation for profit under the Florida General Corporation Act, hereby adopt the following ARTICLES OF INCORPORATION.

ARTICLE I NAME

The name of this Corporation shall be: A & H BEEPER & CELLULAR ACCESSORIES, INC. and its business shall be carried on in BROWARD COUNTY, FLORIDA, and also within and without the STATE OF FLORIDA, and in the UNITED STATES OF AMERICA and FOREIGN COUNTRIES as may from time to time be deemed desirable or expedient.

ARTICLE II TERM OF EXISTENCE

This Corporation shall have perpetual existence unless dissolved by action of law or by vote of the stockholders.

ARTICLE III NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation and the objects and purposes thereof are as follows:

- The transaction of any and all lawful business for which corporations may be incorporated under chapter 607 of the State of Florida Statutes.

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

The amount of capital with which this corporation shall begin business shall be not less than one hundred (\$100.00) dollars.
