ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE: CORPORATE NAME

The Corporation name is PACIFIC FOOD AND BEVERAGE, INC.

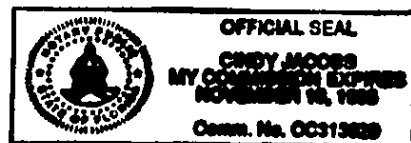
