# ARTICLES OF INCORPORATION

# SUNDIAL INC.

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

# ARTICLE I

The name of this corporation shall be SUNDIAL, INC., and the initial address of this corporation shall be 934 N. University Dr., Suite 215, Coral Springs. Florida 33071.

# ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

# ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all the said stock shall be payable in cash, property, real or personal. labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

Upon the sale for cash of any new stock of the same kind, class or series as that which he already holds, every stockholder of this corporation shall have the pre-emptive right to purchase his pro rate share thereof at the price which it is offered to others, whether or not in excess of par. Fractional shares need not be issued on account of this provision.

# ARTICLE IV

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless somer dissolved according to law.

### ARTICLE V

The initial registered office of this corporation shall be at 934 N. University Dr., Suite 215, Coral Gables, Florida 33071, with the privilege of having its offices and branch offices at other places within or without the State of Florida.
