




# ARTICLES OF INCORPORATION

OF

PETAL HEAVEN FLORIST, INC.



The undersigned hereby associate for the purpose of becoming a corporation for profit under the laws of the State of Florida in compliance with Florida Statute §607.0202.

# Article I

The name of the corporation shall be Petal Heaven Florist, Inc.

# Article II

The mailing address of the principal office of the corporation shall be:

# Article III

The corporation is being formed for the purpose of being a florist shop, as well as to engage in any other activity or business permitted under the laws of the State of Florida.

#### Article IV

The amount of capital stock of the corporation shall be One Thousand (1,000) shares of common stock with a par value of One Dollar (\$1.00) per share.

# Article V
