* ARTICLES OF INCORPORATION * for * TRRS, INC. *

In compliance with the requirements of F.S. Chapter 607, the undersigned, JOHN DAVID TYO, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I

The name of the Corporation is TKRS, INC.

ARTICLE II

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida.

ARTICLE III

The street address of the initial principal office of the corporation is located at 188 Dublin Drive, Lake Mary, Florida 32746. The initial mailing address of the Corporation is also 188 Dublin Drive, Lake Mary, Florida 32746.

ARTICLE IV

The maximum number of shares of stock that this company is authorized to issue and have outstanding at any one time is One Thousand (1000) shares of voting common stock having no par value. ARTICLE X




