# ARTICLES OF INCORPORATION OF Bee & Bee PLUMBING MAINTENANCE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I NAME

The name of the corporation shall be Bee & Bee PLUMEING MAINTENANCE, INC.

# ARTICLE II NATURE OF BUSINESS

This corporation may engage in or transact any and all assume that activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation. The corporation shall have and exercise all the corporate powers enumerated in or otherwise permitted under the Florida General Corporation Act.
