**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be FEIMAN & HOLLIDAY, INC. and its principal business and mailing address is 10 San Juan Circle, Ponte Verda, Florida 32082.

The term of existence of the corporation is perpetual.
