ARTICLES OF INCORPORATION OF ALPHABET SOUP, INC.

ARTICLE I - NAME

25 July 13 M 3 04 The name of this corporation is Alphabet Soup, Inc. (the "Corporation").

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE IV - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
