

The undersigned incorporators, for the purposes of forming a Corporation under the Florida Business Corporations Act, hereby adopt (s) the following Articles of Incorporation:

ARTICLE I: NAME AND PRINCIPAL ADDRESS

The name of the corporation shall be SANDERS & LYNN GUIDES TO ADVENTURE, INC. The principal address of the corporation will be 1290 Weston Rd., Suite 210, Fort Lauderdale, Florida 33326.

ARTICLE II: DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III: PURPOSE

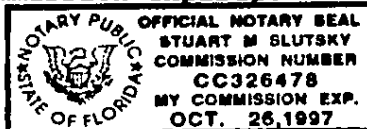
