

OF

THE UNDERSIGNED, for the purpose of forming a corporation for profit under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is:

**ARTICLE II
DURATION**

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State of Florida.

**ARTICLE III
PURPOSES**

This corporation is organized for the purpose of purchasing, acquiring, developing, and investing in real property and to transact such other lawful business as the owner may wish to pursue.

**ARTICLE IV
CAPITAL STOCK**

This corporation is authorized to issue 100 share of \$1.00 par value common stock.

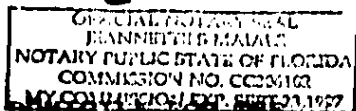
