ARTICLES OF INCORPORATION

OF

ADVANTAGE AMERICA CORPORATION

ARTICLE I

The name of this corporation shall be ADVANTAGE AMERICA CORPORATION, and the principal place of business shall be 1718 E. 7th Avenue, Suite 301, Tampa, Florida 33605.

ARTICLE II
