ARTICLES OF INCORPORATION OF SOMETHING VENTURED ENTERPRISES, INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1.

Name.

The name of the Corporation is: Something Ventured Enterprises, Inc.

Article 2.

Location.

The principal office and mailing address of this corporation shall be: 7041 W. Broward Boulevard - Unit 27, in the City of Plantation, County of Broward, State of Florida; or such other location as shall be determined by the Board of Directors from time to time.

Article 3.

Duration.

The duration of the Corporation is perpetual.

Article 4.

Purpose.

The general purposes for which the Corporation is organized are the following:
