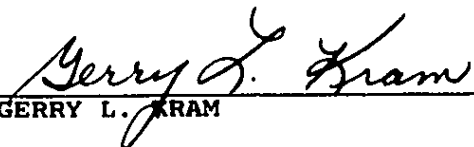
ARTICLE IX
