**ARTICLES OF INCORPORATION
OF
RUTH MINZER DAVIDSON, P.A.**

The undersigned, acting as Incorporator for the purpose of forming a Professional Corporation under the provisions of the Florida Business Corporation Act ("Corporation Act") and the Florida Professional Service Corporation and Limited Liability Company Act ("Professional Corporation Act"), does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME**

The name of the professional corporation is Ruth Minzer Davidson, P.A. (hereinafter called the "Corporation").

**ARTICLE TWO
PRINCIPAL OFFICE**

The principal office and mailing address of the Corporation is 111 Second Avenue, N.E., Suite 1201, St. Petersburg, Florida 33701.

**ARTICLE THREE
DURATION**

The duration of the corporation is perpetual.

**ARTICLE FOUR
PURPOSE**

The Corporation is organized for the purpose of rendering legal services and for transacting any and all other lawful business under the Florida Business Corporation Act and the Professional Corporation Act.

**ARTICLE FIVE
CAPITALIZATION**

The aggregate number of shares of all classes of stock which the Corporation is authorized to issue is 100 shares of Common Stock, par value \$1.00 per share.

**ARTICLE SIX
REGISTERED OFFICE AND AGENT**

The address of the Corporation's initial registered office is 111 Second Avenue N.E., Suite 1201, St. Petersburg, Florida 33701, and the name of its initial registered agent at such office is Ruth Minzer Davidson.

**ARTICLE SEVEN
DIRECTORS**

Section 1. The business of the Corporation shall be managed by a board of directors. The number of directors on the Board of Directors shall be set forth in the by-laws of the Corporation, as hereafter adopted and amended by the shareholders of the Corporation. The number of directors constituting the Corporation's initial Board of Directors shall be one.

**ARTICLE EIGHT
INCORPORATOR**

**ARTICLE NINE
INDEMNIFICATION**

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
