Name

The name of the corporation is **DIAMONDBACK RANGE SAFETY PRODUCTS, INC.**

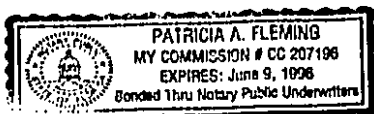
