# ARTICLES OF INCORPORATION

OF

# A FLORIDA CORPORATION

## ARTICLE I

## NAME AND ADDRESS

The name of this corporation is RCTV Holdings, Inc., and its principal place of business shall be at 5979 Vineland Rd., Suite 325, Orlando, FL 32819, but it may have and maintain other such places within the United States and elsewhere as its Board of Directors may, from time to time, determine necessary.

## ARTICLE II

## DURATION

The period of the duration of this corporation is perpetual.

## CORPORATE PURPOSE
